# **GENERAL**

## 1.1 What's new in ReaxFF 2019

ReaxFF is available in the AMS driver as one of the engines, which means that all tasks that can be performed with the AMS driver are also available for ReaxFF. However, not all tasks available in the classic ReaxFF standalone program have already been ported to AMS, so in the 2019 release of the Amsterdam Modeling Suite, the standalone ReaxFF program and the ReaxFF engine coexist. This manual mostly describes the standalone ReaxFF program. For documentation on how to use ReaxFF in AMS, see the special page on *ReaxFF as an AMS engine* (page 41) as well as the AMS driver manual.

Development of the *standalone* ReaxFF program has been stopped, so there are no new features in the 2019 version.

2 Chapter 1. General

## **ENSEMBLES**

Currently the following ensembles are implemented in the ReaxFF program:

- NVE
- NVT with a Berendsen thermostat (see the original reaxff pdf manual for details)
- NVT with a Nose-Hoover chain (NHC) thermostat
- NPT with a Berendsen baro- and thermostat (see the original reaxff pdf manual for details)
- Anderson-Hoover (AH) or Parrinello-Rahman-Hoover (PRH) NPT with NHC thermostats

The ensemble is selected based on the imdmet value in the control file. Currently supported imdmet values are:

- 1 Berendsen NVT
- 2 Nose-Hoover chains NVT
- 3 Microcanonical ensemble (NVE)
- 4 Berendsen NPT
- 9 Isotropic NPT with MTTK NHCP
- 10 Anisotropic NPT with only the length of the unit cell vectors changing and MTTK NHCP
- 11 Anisotropic NPT with full cell fluctuations and MTTK NHCP

The following imdmet values are also recognized by the program but the corresponding functionality has not been tested by SCM and is thus not supported (they come directly from the Adri van Duin's code):

- 5 NVE with a switch to NVT when the average system's temperature exceeds a certain target
- 6 Hugoniostat
- 7 NVE with shear force
- 8 non-equilibrium NVE with the ab plane moving every step by a fixed amount

The selected ensemble can further be modified using other control keys: itdmet, inpt (for anisotropic NPT), mdtemp (target temperature, K), tdamp1 (T damping constant, fs), mdpres (target pressure, MPa), pdamp1 (P damping constant, fs), and some other. Furthermore, the NVT ensembles can further be modified using the so-called temperature regimes (T-regimes) specified via a tregime.in file.

# 2.1 Nose-Hoover chains NVT ensemble

Both the NHC-NVT and the AH-NPT are implemented following the paper by G.J. Martyna et al. [G J Martyna, M E Tuckerman, D J Tobias, M L Klein, Mol. Phys. 87 (1996) 1117]. The following parameters are used: N\_c=5, N\_ys=5, Nchains=10. The NHC-NVT ensemble is invoked by setting imdmet=2 in the control file. The tdamp control

parameter  $(\tau_t)$  is used to determine the first thermostat mass as  $Q = N_{free}kT_{set}\tau_t^2$ . It should be noted that the  $\tau_t$  in the Nose-Hoover method corresponds to the period of the characteristic oscillations of the system, which is different from the  $\tau$  in the Berendsen thermostat where it determines the relaxation time. Relaxation of the system with a Nose-Hoover thermostat usually takes longer than with the Berendsen one with the same  $\tau$ .

The temperature regimes and zones specified via the tregime.in file can also be used with the NHC thermostat the same way as with the Berendsen one.

## 2.2 AH and PRH NPT ensemble with NHC

The Anderson-Hoover NPT ensemble is invoked by setting imdmet=9 in the control file. Everyting writien above about the NHC thermostat applies also to the thermostat part of the AH-NPT. The particle thermostat and the barostat are controlled by two different chains. The masses in the barostat thermostat chain are determined by the tdamp parameter as  $Q_p = kT_{set}\tau_t^2$ . The pdamp control parameter  $\tau_p$  defines the barostat mass as  $W = (N_{free} + 3)kT_{set}\tau_p^2$ . Similar to the NHC thermostat, the  $\tau_p$  here corresponds to the period of the characteristic pressure fluctuations of the system.

For an anisotropic (Parrinello-Rahman-Hoover) NPT dynamics one should specify imdmet=10 (fixed cell angles) or imdmet=11 (full cell fluctuations). It should be noted that the anisotropic NPT dynamics has not been well tested yet and thus it should be considered experimental. For imdmet=10 one can additionally freeze one or more axes using the inpt control parameter. The supported values are identical to those used for the Berendsen NPT: 1, 2, 3 to keep a, b, or c fixed, respectively, and 4 to keep both a and b fixed.

# 2.3 Berendsen NVT with separate damping for translational, rotational, and vibrational degrees of freedom

It is possible to equilibrate translational, rotational, and vibrational degrees of freedom separately from each other. This may be necessary, for example, in the case where the initial state of the system contains many quickly spinning molecules with a relatively small translational velocity. The usual equilibration of such a system would take a lot of time due to the low translational velocity of the molecules. This mode is invoked by setting imdmet=1 and itdmet=7 in the control file.

## **EREAXFF: CLASSICAL TREATMENT OF THE EXPLICIT ELECTRON**

The eReaxFF implementation in the SCM ReaxFF program is based on the paper [J. Chem.Theory Comput 12, 3463 (2016) (https://doi.org/10.1021/acs.jctc.6b00432)] and on the prototype code obtained from the group of Adri van Duin. It was, however, largely rewritten by SCM to meet our coding standards and to maximize performance.

An eReaxFF calculation requires the following additional force-field parameters to be defined (equation numbers are referring to the eReaxFF paper):

- The header of the force-field file must begin with the "[ ereaxff acks2 ]" string,
- General parameter 27: the currently reserved  $p_{elho}$  parameter in the unpublished electron-hole interaction equation (which is still highly experimental and is subject to change),
- General parameter 37: the Gauss exponent parameter  $p_{val}$  describing the free electron, Eq(3),
- General parameter 41: a different taper radius for electron and hole interactions can be specified here,
- Atomic parameter 24: the  $\alpha$  parameter in Eq(2),
- Atomic parameter 27: the  $\beta$  parameter in Eq(2),
- Atomic parameter 13: the  $p_{ij}^{xel2}$  parameter in Eq(4d),
- Bond parameter 16: the  $p_{ij}^{xel1}$  parameter in Eq(4d).

Additionally, since the eReaxFF method is usually coupled to the ACKS2 charge equilibration method, the ACKS2-related parameters should also be defined.

In the input geometry file, the explicit electrons are called 'El' and the holes are 'Ho' (yes we are aware that the latter clashes with holmium but this is what the original authors are using).

It should be noted that the eReaxFF implementation is considered experimental so the users are advised to contact Adri van Duin regarding its use.

# 4.1 Vibrational Frequencies

## 4.2 Per-atoms Stress Tensor

The per-atom stress tensor is calculated according to Thompson, Plimpton, Mattson, J Chem Phys, 131, 154107 (2009) (https://doi.org/10.1063/1.3245303) . when the lstres control parameter is set to a non-zero value.

The calculated stress tensor is stored in the rxkf file in the "History%Atomic stress xxxx" variable, where xxxx corresponds to a step number, in units of MPa or MPa \* A3, depending on the lstres value in the ReaxFF control file:

- 1 1stres (GUI: Stress energy) the stress times volume value per atom  $S\alpha\beta$  is calculated as a sum of the per-atom virial and the kinetic energy term:  $S\alpha\beta=mv\alpha v\beta+F\alpha r\beta$ .
- 2 1stres (GUI: *Stress*) the result is equal to  $S\alpha\beta/V$ , where V is atomic volume calculated using the Voronoi partitioning scheme.

The temporal average atomic stress values are stored in "History% Average atomic stress xxxx". The tensors are saved as follows: six components (xx, yy, zz, yx, zx, zy) for the 1st atom followed those for the 2nd one, and so on.

See the ReaxFF stress strain tutorial for an application of the per-atom stress tensor.

# 4.3 NEMD Methods for Thermal Conductivity

There are different methods to study thermal conductivity using non-equilibrium molecular dynamics (NEMD). In ReaxFF, two methods are implemented. A common feature of these methods is that they require the system to be divided into three or more zones, each with its own thermostat and/or other properties. Both methods make use of the *tregime.in* file to define the zones and their properties. The first method maintains the temperature of the heat source and the heat sink zones at the given temperature using two different thermostats and measures the amount of heat transferred. This method is invoked by setting the *itdmet* control parameter to 2, which is the default value. The format of the *tregime.in* file for this method is as follows:

In this example, atoms 1-7520 form the heat conduction zone, zone1. This zone is not thermostatted (the NVE ensemble is used), which is specified by a zero value for the temperature damping parameter damp. The zone2 (atoms 7521-7680) is a heat source and its temperature, 500K in this case, is maintained by the thermostat specified by the *imdmet* control parameter (1 for Berendsen and 2 for NHC). The zone3 (atoms 7681-7840) is the heat sink whose temperature is maintained at 300K. In the steady state, a temperature gradient will evolve through the conduction zone and the amount of heat transferred through it per unit of time should be equal to the amount of heat added to the heat source zone, and to the heat removed from the heat sink zone. The total heat added or removed for each zone by the corresponding thermostat is written to the fort.75 file.

The second method (which is available in two variants) is invoked by setting *itdmet* to 8 or 9. There is no thermostat as such involved here, which means that the *imdmet* control parameter must be set to 3 (NVE ensemble). Instead of controlling the zone's kinetic energy based on the temperature, the heat source zone is added (and the heat sink is subtracted) a fixed amount of kinetic energy each step. Currently there are two variants of this method implemented: a simple heat pump (*itdmet* = 8), where atom velocities are simply scaled when adding or removing the kinetic energy, and the HEX method by Ikeshoji and Hafskjold in which the velocities are scaled in such a way as to keep the velocity of the center of mass of the zone constant. It should be noted that the HEX introduces a small energy drift. The format of the *tregime.in* file for these two method is almost the same as for the first method with some differences: the Tset and damp parameters are ignored and the dT value becomes dQ (in kcal/mol per MD step):

The zone assignment in this example is the same as in the previous one. One should be careful when choosing values for dQ because a too large positive value may lead to pyrolysis of the heat source and a too large negative value may lead to abnormal termination when all kinetic energy of the heat sink has been drained.

For all these methods, in order to calculate the thermal conductivity value one needs to divide the heat flow rate by the temperature gradient and by the flow cross-section area:  $k = W/(S \cdot grad(T))$ . In the first method the heat flow rate can be calculated from the thermostat energy values found in the fort.75 file (or rather their derivative w.r.t. the time). In the heat pump and the HEX methods the heat flow rate is defined by the dQ value andby the time step parameter directly:  $W[Watt] = 6.94122 \cdot 10^{-6} dQ/dt$ , where dQ is given in kcal/mol/step and dt is the time-step in fs. See below on how to determine the temperature gradient along an axis.

# 4.4 Temperature Profile along Coordinate Axis

The temperature profile along the simulation box axes will be calculated when ianaly=2 is set in the control file. In the tprofile out file found in the results directory, the average temperatures along each box axis are listed in the following format:

Here, "Cell coord" is the coordinate of the middle point of the corresponding length interval (the bin), N(sample) is the number of samples used in the averaging (which is done over the time and the atoms in the bin), and T(ave) is the average temperature in the bin over the time interval. The time interval and the number of bins are determined by the iout7 and tprofp control parameters, respectively. It should be noted that the binning of atoms is done in fractional coordinates, which means that the plane separating two bins, for example, along the c crystal axis is always parallel to the c axis itself.

The profile is also saved to the KF result file. The corresponding variables in the History section are "T profile X YYYY", when "X" specifies the profile axis and is one of "a", "b", or "c" and "YYYY" is the MD step number.

# 4.5 Local Atomic Temperature

ReaxFF can calculate atomic temperatures and spatial averages thereof. Individual atomic temperatures are saved with the trajectory by default and these can be visualized by ADFmovie. However temperatures of individual atoms can vary significantly, which may result in a not so clear picture. To see trends in the spacial distribution of the temperature across the system it may be useful to display an average temperature of the atom and its neighbors instead. The spacial averaging is activated by specifying the following keywords in the control file:

# 4.6 Adsorption Analysis

Analysis of the molecular composition of the system under study normally includes all atoms. In the original ReaxFF, it was already possible to ignore a certain type of atoms when performing the analysis, which may help analyze surface dissociation reactions. For example, in an Al-H2O system, one can distinguish a physisorbed water molecule from a surface-dissociated one by excluding all aluminum atoms from the molecular analysis. However, this feature cannot be used for surfaces consisting of atoms of more than one type and it will also not distinguish a surface reaction from the same reaction taking place off the surface.

The new type of analysis is intended to fill this gap. This analysis is triggered by specifying a range of atoms as a "support" in the input geometry (in the BGF format):

```
SUPPORT startAtom endAtom
```

Here, startAtom and endAtom are indices of the first and the last atoms of the range constituting the support (surface+bulk) part of the model system. Multiple SUPPORT keys are allowed in the input file, in which case they will all be merged into one "support" entity. If this key is present, the molfra.out file will contain something like this (taking again the Al-H2O system as an example and treating the Al slab as a support):

The "H2O(ads)" must be understood as a water molecule adsorbed on a surface via its oxygen atom. During dynamics one may also see molecules such as HH(ads)O(ads), where both H and O atoms interact with the support. In other words, the "(ads)" suffix applies to the atom preceding it and, through this atom, to the whole molecule. As usual in this kind of analysis in ReaxFF, two atoms are considered connected if the order of the bond between them is greater than the cutof3 control parameter.

# 4.7 On-the-fly Analysis of Reaction Events

Built-in reaction detection and analysis in reaxff is enabled by setting the *ibocha* control parameter to a non-zero value. This method is based on keeping track of the number of bonds of atoms in the system at set intervals, which guarantees a very low overhead in almost all cases. When the number of bonds around an atom changes this atom becomes an atom of interest and the output is written to bondchange.out and possibly reactions.xyz. The molecular composition analysis is performed every iout7 steps and results are both saved as part of the trajectory and used for the analysis described here. For this reason the kf-file sampling interval parameter iout7 also defines the frequency of the on-the-fly reaction detection.

Two ibocha values are currently supported: 1 and 2. The ibocha=1 does the same as in the original reaxff version: printing to bondchange.out a one-line message for each atom with changed number of bonds, like this:

The ibocha=2 option is an extension to ibocha=1 and it tells reaxff to also dump the xyz coordinates of molecules mentioned above to the reactions.xyz file. For the example above, two molecules would be written:

In the example above, the first molecule, C5H8O12N4 denoted as "reactant", is the molecule that contained atom N 15

at the previous sampling step. The second molecule, NO2 denoted as "product", is the molecule that contains the atom at the current step. Thus, the xyz coordinates of the "reactant" molecules is always iout7 steps behind the coordinates given for the "products".

**Note:** The choice of the iout7 sampling frequency is very important for a correct analysis. Too small iout7 value (frequent sampling) may lead to many forth-and-back "reactions" detected, which are merely stretched bonds due to some very hot vibrations. A too large iout7 value (rare sampling) meay lead to some elementary reactions being missed and merged into "collective" events.

**Note:** The low-overhead bonding analysis method used here may miss events that do not result in the change of the number of bonds on an atom. For example, concerted reaction of proton transfer in a ring of water molecules will likely go unnoticed because the number of bonds remains the same on every atom, even though the bonds do change.

# 4.8 Trajectory Analysis

## 4.8.1 ChemTraYzer

#### **General information**

The ChemTraYzer scripts, developed in the Leonhard group (http://www.ltt.rwth-aachen.de/forschung/molekulare\_thermodynamik/molekulare\_thermodynamik/project/ChemTraYzer\_Modellierung\_chemi/) at Aachen University, provide a methodology for deducing quantitative reaction models from reactive molecular dynamics simulations by identifying, quantifying, and evaluating elementary reactions of ReaxFF trajectories.

For usage with ADF's ReaxFF the scripts have been slightly modified and use RDKit instead of the openbabel-bindings. A GUI-tutorial is available here. The original paper, Automated Discovery of Reaction Pathways, Rate Constants, and Transition States Using Reactive Molecular Dynamics Simulations, can be found here (http://dx.doi.org/10.1021/acs.jctc.5b00201).

### **Command line execution**

- 1. Open a terminal:
  - on Linux: Ctrl+Alt+T usually works, otherwise browse your application menus
  - on Windows: double click adf\_command\_line.bat in your ADF installation directory (e.g. C:/ADF2016.106), enter 'sh' to go to a shell
- 2. cd into the directory where your trajectories are located with the terminal
- 3. Assuming your trajectory file is called traj.rxkf, running ChemTraYzer is a two step procedure
  - run the processing step (with default values)

 $ADFBIN/startpython ADFHOME/scripting/standalone/chemtrayzer/processing_scm.py traj.rxkf$ 

• run the analysis step (with default values)

\$ADFBIN/startpython \$ADFHOME/scripting/standalone/chemtrayzer/analyzing\_scm.py traj.rxkf

You will probably want to adjust the settings. A list of all available options is shown by calling the scripts without arguments, e.g. \$ADFBIN/startpython \$ADFHOME/scripting/standalone/chemtrayzer/analyzing\_scm.py

#### Results

ChemTraYzer creates several output files, the most relevant ones being:

#### reac.spec.tab

1st line: indices of the species, e.g. S1;S2;S3;etc...

2nd line: SMILES of the species, e.g. ;C;CC;CCO;CCOO;CO;O;[H];etc...

3rd - end: timestep, counts of the species, e.g. 150;0;0;2;... // step 150, current count of S3 == 2

#### reac.rate.tab

1st line: indices of the reactions, e.g. t [steps];R0;R0\*;R1;R1\*; // a "\*" marks the back reaction

2nd line: the reactions formulated with the species indices, e.g. S0 + S0 + S0 + S13 -> S65; // see reac.spec.tab

3rd line: the reactions formulated with sum formulas, e.g. CH3 + H -> CH4, etc...

4th -...: timestep; rate constant of the reaction; rate constant of the back reaction; etc...

#### reac.pic/

folder containing the 2D structures (if obabel was able to create them) reac.pic/xyz/ xyz files of the species as they first appeared in the trajectory

# 4.8.2 TRAVIS: A Trajectory Analyzer and Visualizer

TRAVIS is a command line C++ program for analyzing and visualizing trajectories from all kinds of Molecular Dynamics or Monte Carlo simulations developed by M. Brehm (J. Chem. Inf. Model. 51(8) (2011) (https://doi.org/10.1021/ci200217w)). TRAVIS is shipped with the ADF modeling suite from on ADF2017.

The supported input formats of TRAVIS are:

- xyz
- pdb
- *lmp* (Lammps)
- HISTORY (DLPOLY)
- prmtop/mdcrd (Amber)

With ADF2017 the analysis of DFTB and ReaxFF trajectories is supported.

Note: TRAVIS was designed with non-reactive trajectories in mind, thus one needs to make sure that:

- either the composition of the target species does not change, e.g. by analyzing only a suitable time-interval or running non-reactive dynamics
- or the analysis does not depend on the detection of a particular species, e.g. the diffusion of (inert) atoms

In order to run a TRAVIS analysis on your trajectory open a shell and navigate to the folder you ran your calculation in. Use the python script **kf\_to\_xyz.py** to convert your trajectory into a TRAVIS-compatible XYZ-format.

Assuming the trajectory is called traj.rxkf, run:

```
$ADFBIN/startpython $ADFHOME/scripting/trajectory_analysis/kf_to_xyz.py
traj.rxkf
```

This step will create a file called **traj\_travis.xyz** that contains the frames in XYZ format plus an additional 5th column containing the ReaxFF atomic charges.

Next, start TRAVIS to enter an interactive dialog:

```
$ADFBIN/travis.exe -p traj_travis.xyz
```

An example of how to use TRAVIS with ReaxFF can be found in the advanced Li-Batteries ReaxFF tutorial (https://www.scm.com/news/tutorial-li-ion-diffusion-coefficients-reaxff/).

# FF OPTIMIZER: FRAMEWORK FOR FORCE FIELD PARAMETER OPTIMIZATION

The FF Optimizer is a base module that can be extended with other modules that implement specific optimization methods. The base FFOptimizer module offers methods to compute the cost function (also known as the error or the fitness function) and its first and second derivatives with respect to the force-field parameter values. Besides that, there are two extensions available that implement global optimization methods: Monte-Carlo (MCFF) and Covariance Matrix Adaptation Evolution Strategy (CMA-ES).

# 5.1 Input files common for all optimizers

In order to optimize a ReaxFF forcefield, the files listed below must be present in the directory where the reaxff program is executed.

- *iopt* file containing a line of text with a single number on it. To use the basic FFOptimizer features this file must contain 6. See the *ffoact* description below for more details.
- ffield (page 77)- the initial force-field file.
- *control* in addition to general ReaxFF control parameters it may also contain the FFOptimizer-related ones explained in the corresponding sections.
- *trainset.in* (page 81) file with test values from the training set, the same as in the original reaxff force-field optimization, see page 27 of the ReaxFF User Manual.
- params file that describes variable forcefield parameters, one line per parameter (see example below).

This format is a generalization of the original params file format.

The hash symbol '#' starts a comment. Each non-comment line must begin with three integer numbers, the section-block-item coordinates of the corresponding parameter. The first coordinate specifies a section: 1 - general parameters, 2 - atomic parameters, 3 - bonds, 4 - off-diagonal terms, 5 - valence angles, 6 - torsion angles, 7 - hydrogen bonds. The second coordinate specifies a block within the given section or an item index for the general parameters section (section=1). The third coordinate specifies an item index within the block, except for section 1 for which the third coordinate is ignored. The coordinates can optionally be followed by a one or more real number. The number and the meaning of the reals depends on the selected task. For some force-field optimization methods the first three real number have a special meaning referred to as *delta* (or *sigma*), *ffmin*, and *ffmax* in the following sections, respectively. A params file can be generated using the *rxffutil utility* (page 35).

An example of the params file:

- *ffield\_bool* an alternative way to specify variable parameters if the params file is not present. This file has the same format as ffield but instead of parameter values it contains 1.0 or 0.0 as a flag whether the corresponding value is to be variable or not, respectively.
- ffield\_min an alternative way to specify minimum values (ffmin) for the variable parameters if the params file is not present. This file has the same format as ffield.
- ffield\_max an alternative way to specify maximum values (ffmax) for the variable parameters if the params file is not present. This file has the same format as ffield.
- *geo* file with the training set geometries in the BGF format, the same as in the original reaxff force-field optimization. Geometries of different molecules in this file must be concatenated.
- *models.in* as an alternative to a single *geo* file one can save each geometry in its own file and list the files that are part of the training set here. The molecule name specified in the *models.in* file must match that in the *trainset.in* file and it takes precedence over any molecule name specified inside the geometry file (filename1, etc.). The format of the file is as follows:

```
filename1 MoleculeName1 filename2 MoleculeName2 ...
```

# 5.2 Control parameters common for all optimizers

The following control parameters are related to the FFOptimizer. The default value for each parameter is given in parentheses.

- ffoact the task ID to be performed by the base FFOptimizer module (i.e. when the iopt file contains 6):
  - 1 calculate gradient of the error function with respect to the variable FF parameters by finite differences. This option requires 2\*N + 1 error function evaluations, where N is the number of variable force-field parameters.
  - 2 calculate the second derivatives (Hessian) matrix of the error function with respect to the variable FF parameters by finite differences. The eigenvalues and eigenvectors of the obtained Hessian matrix will also be computed. In this case, N^2 + N + 1 function evaluations will be done. Note: a calculation of derivatives can be very slow so make sure you run it on as many processors as possible.
  - 3 calculate an error function value for each column-vector of parameters specified in the *params* file. If the params file does not contain any column-vectors (i.e. there are no real numbers at all in the file) then the error function for the current ffield file is calculated. This feature can be used, for example, by external force-field optimizers. The result per trainset in entry is written to the fort.99 file.
  - 4 find *replic* random vectors of parameter values that result in a valid (non-NaN) error function value. The random values are distributed uniformly in the allowed parameter space.
- ffostp the delta used for calculating first and second derivatives by finite differences (0.01).

The following options may apply to any FF optimization type.

• ffdedi - If running in parallel and ffdedi is set to 1 then the master process will run as a dedicated dispatcher and will not perform any computations. The default value depends on the number shared-memory nodes used in the calculation (0 for single-node calculation, 1 otherwise).

- replic number of parameter sets to calculate at once for ffoact = 4 (1 by default). This control parameter may have different meaning and defaults for other force-field optimizers.
- fort99 if this parameters is set to 0 then the fort.99 files will not be written. By default, every fitness function evaluation produces a fort.99.xxx.yyy file, where xxx is an iteration number and yyy is a replica index at the iteration. This may potentially lead to a large number of fort.99.\* files so setting fort99 to 0 can be useful for saving space in long production runs.
- fort90 MCFFOptimizer will create a geo file with optimized geometries corresponding to the current best parameter set.

# 5.3 MCFF Optimizer: Monte Carlo force field parameter optimizer

The MCFF Optimizer uses a Monte Carlo approach to finding the best fit force field for the given training set. It is based on the paper by E. Iype et. al. (https://doi.org/10.1002/jcc.23246) In the following sections, the input and output of the MCFF Optimizer are described.

A worked out example on building a training set and optimizing a ReaxFF force field with MCFF is on our workshop pages (https://www.scm.com/adf-modeling-suite/adf-hands-on-workshops/advanced-2-day-reaxff-workshop/).

# 5.3.1 Input files

In addition to files specified in the FF Optimizer section the following files must be present in the directory where the reaxff program is executed.

• *iopt* - file containing a single text line with 4 on it. This will instruct reaxff to perform a Monte-Carlo force-field optimization.

The mcffopt\_water example in the examples/reaxff directory demonstrates the use of the MCFFOptimizer. Note however that this example is not physically meaningful. For example, many atomic force-field parameters are allowed to vary in a very broad range, which is the same for all elements. In practice, you will want to set the range for each element separately.

## 5.3.2 Control parameters

The following control parameters are related to MCFFOptimizer. The default value for each parameter is given in parentheses.

- *mcffit* number of MC iterations (10000). Since the Monte-Carlo method does not have any notion of convergence the optimization is stopped after mcffit iterations.
- mcbeta initial MC beta parameter in the acceptance probability calculation  $P = exp(-\beta \Delta E)$  (0.0). Here,  $\Delta E$  is a difference in the error function between the current and the best step so far. If the current step is the best, it is always accepted. Otherwise, the acceptance probability is calculated using the formula above and it is calculated with a random number from the (0,1) range. The optimal value of beta depends on values of the error function. If absent or set to 0, it will be calculated after the first step as  $\beta_0 = \sqrt{\frac{N_{par}}{2} \frac{1}{E_0}}$ , where  $N_{par}$  and  $E_0$  are the number of variable parameters and the initial error function value, respectively.
- *mcdbet* simulated annealing: increase the beta parameter by this value at each step (0.0). A positive mcdbet value means that the probability to take a step that increases the error function will decrease over time. This has the same effect as decreasing the temperature in the classical molecular Monte-Carlo method.

- mcbsca simulated annealing: divide the beta parameter by this value at each step (1.0). A value of mcbsca less than 1.0 has an effect similar to positive mcdbet. If mcbsca is set to 0, it will be calculated after the first step as  $\frac{\beta_n}{\beta_{n+1}} = \sqrt[N_{step}]{\frac{5}{E_0}}, \text{ where } N_{step} \text{ and } E_0 \text{ are the number of steps and the initial error function value, respectively.}$
- *mcacpf* probability to vary a variable at each step (0.2). To avoid taking very large steps only some of the variables are varied at each step (selected randomly).
- mcrxdd number of intervals to divide the parameter range between ffield\_min and ffield\_max into (100).
- mcstep initial max step size in units of range/mcrxdd, where range = difference between ffield\_max and ffield min values (1.0).
- mcmxst maximum allowed value of max step size (100);
- mcscps factor to scale max step size to satisfy acceptance tolerance (1.1);
- *mctart* target acceptance rate, percent (30.0);
- *mcmart* max acceptance rate, percent (70.0);
- *mcmini* if not 0, minimize the best force-field parameter set after so many iterations (0). The optimization is performed only if the best set has changed since the previous minimization. The minimization employed here is gradient-free and relatively slow so it should not be used too frequently.
- replic number of replicas to try at each step (1). At each step, replic Monte-Carlo steps are done and the one with the lowest error is selected for the next iteration.

Relation between mcrxdd, mcstep, mcmxst, and mcscps. When the parameter ranges are given via ffield\_max and ffield\_min files, the range for each parameter is divided into mcrxdd intervals. The step taken is a uniformly distributed random value in the range  $(-\Delta x, \Delta x)$ , where  $\Delta x = mcstep*(Xmax - Xmin)/mcrxdd$ . Here, Xmax and Xmin are values of this parameter from ffield\_max and ffield\_min, respectively. When the parameter range is given via a params file then  $\Delta x = mcstep*delta$ , where delta corresponds the first real number in the params file. When performing optimization, the program keeps track of the average acceptance rate and adjusts mcstep up or down by the mcscps factor to keep the acceptance rate close to mctart. If the acceptance rate is too low the step size is decreased to allow searching for a smaller parameter space. The mcstep value can never be larger than mcmxst.

It should be noted that the value of the MC step size (and thus all the parameters discussed in this section) applies to all force-field parameters to the same extent, which means that it is very important to select the min and max parameter values very carefully. The rule of thumb here is that the range should be as small as possible covering only the physically meaningful values.

#### 5.3.3 Results

Main results of the MCFFOptimizer are saved in the following files:

- ffield\_best force-field file corresponding to the lowest error value
- · ffield last the most recent accepted force-filed
- MCFFOptimizer.log summary of iterations including the error function value, number of changed and bounded
  force-field parameters, cumulative number of accepted and rejected steps at each step. Also the current MC
  parameters such as the β value and the acceptance rate, are shown, as well as the elapsed time in seconds.
- fort.99 the error function breakdown for the latest step
- fort.90 if fort90 is set in the control file, geo file with optimized geometries corresponding to the current best parameter set

## 5.3.4 Run-time control

The progress of the force-field optimization can be controlled by changing parameters in the *istop* file present in the calculation directory. The file is read every 10 iterations. The parameters are explained below:

- StopKey replace 0 with 1 to stop the calculation
- Beta the current  $\beta$  value corresponding to the *mcbeta* control parameter
- Command one of: NONE, WALK, JUMPWALK, MINIMIZE, JUMPMINI:
- NONE no change in the procedure
- WALK switch to Monte-Carlo steps (the default);
- MINIMIZE switch to gradient-free minimization of the latest accepted force-field;
- JUMPWALK take the best force-field so far and start the Monte-Carlo procedure from there;
- JUMPMINI take the best force-field so far and minimize it.
- ScaleFactor change the current step size corresponding to the *mcstep* control parameter
- ActiveParameterFraction set the fraction of force-field parameters changed at each step (mcacpf)
- deltaBeta change the current value of the mcdbet control parameter
- BetaScaling change the current value of the *mcbsca* control parameter
- ScaleParSpace change the current value of the mcscps control parameter

# 5.4 CMA-ES Force-field Optimizer

The CMA-ES FFOptimizer uses the Covariance Matrix Adaptation Evolution Strategy to find the best fit force field for the given training set. The current implementation is using the c-cmaes library (https://github.com/CMA-ES/c-cmaes) by Nikolaus Hansen. In the following sections, the input and output of the CMA-ES FFOptimizer are described.

See also: The advanced tutorial on ReaxFF reparametrization.

# 5.4.1 Input files

In addition to files specified in the FF Optimizer section the following files must be present in the directory where the reaxff program is executed.

• *iopt* - file containing a single text line with 7 on it. This will instruct reaxff to perform a CMA-ES force-field optimization.

The following files are optional:

- *cmaes\_restart.txt* a restart file. It should be a copy of the cmaes\_resume.txt file from another calculation. If this file is present the optimization procedure will be restarted where it was left off.
- params If this file is present, it will define the variable reaxff parameters, one line per parameters, as follows:

```
# i j k sigma min max

```

The first three number on a line specify the parameter coordinates (the i,j,k indices). The fourth number is the initial sigma value (the step size) for the given parameter. The fifth and sixth numbers define the range of allowed values for this parameter.

If sigma is less than or equal to zero then it is determined by dividing the range between *min* and *max* by the *mcrxdd* parameter as described below.

Whenever the CMA-ES algorithm makes a trial step outside the given interval, a very large number for the fitness function is returned without performing the calculation. This should "teach" the CMA-ES algorithm to avoid the forbidden part of the parameter space. If at some point the CMA-ES procedure leads to a mean value (the center of the distribution) outside the allowed interval then the optimization stops.

## 5.4.2 Control parameters

For compatibility with the MCFFOptimizer the following control parameters are also applicable to the CMA-ES Optimizer. The default value for each parameter is given in parentheses.

- *ffotol* CMA-ES convergence parameter (1.0e-6). The optimization is stopped when the step-size becomes smaller than ffotol for every parameter.
- *mcffit* max number of iterations (10000). An optimization is stopped when it has converged or after mcffit iterations.
- mcrxdd number of steps to divide the parameter range between ffield\_min and ffield\_max into if the params file is not present (100).
- replic the CMA-ES sample size. The CMA-ES algorithm is designed to use multiple fitness function values at once, called a sample. The sample size should be at least as large as the default calculated as M = 4 + 3 \* ln(N), where N is the number of variables.

Relation between mcrxdd and the step size sigma. When the parameter ranges are given via ffield\_max and ffield\_min files, the initial sigma parameter for CMA-ES is calculated as  $\sigma = (Xmax - Xmin)/mcrxdd$ . Here, Xmax and Xmin are values of this parameter from ffield\_max and ffield\_min, respectively. When the parameter range is given via a params file then  $\sigma$  corresponds the first real number in the params file.

#### 5.4.3 Results

Main results of the CMA-ES Force-Field Optimizer are saved in the following files:

- ffield\_best force-field file corresponding to the lowest error value
- cmaes\_progress.txt a progress file written by the c-cmaes library containing some useful information about the current state of the CMA-ES model.
- fort.73 a log file containing some general output from the ReaxCMAESFFOptimizer module.
- cmaes\_resume.txt a file containing the complete set of CMA-ES model parameters needed to restart the optimization. This file is updated only when a new best-fit force-field is found.
- fort.99 the error function breakdown for the latest step

# ACCELERATING MOLECULE DYNAMICS AND OTHER RELATED METHODS

# 6.1 Grand Canonical Monte Carlo (GCMC)

#### 6.1.1 General info

**Tip:** Take a look at the GCMC tutorial and learn how to setup a GCMC calculation.

#### About Monte Carlo / the Grand Canonical Ensemble

It is best to read a bit about Monte Carlo and ensembles before working with the GCMC code. Almost every book or review text on molecular simulations will do, for example: Frenkel D, Smit B. Understanding molecular simulation: from algorithms to applications. Academic Press; 2002. 672 p.

Wikipedia also has some pages of interest:

It is important to note that this method heavily relies on random numbers, and simulations are thus non-repeatable in detail, but should converge to the same answer.

#### About the Reaxff GCMC code

The GCMC code for reaxff was originally developed by Thomas Senftle, working as a Graduate Student at Penn State University under the supervision of Dr. Adri van Duin. The original version was a wrapper code that called an external executable to perform the reaxff minimization step and energy calculation, and relied on file modification and parsing to steer the reaxff code and get the results back.

A rewrite of the code, made by Hans van Schoot (SCM) in close collaboration with Thomas Senftle, is now available in the ADF package. The rewrite directly integrates into the ADF-ReaxFF code, solving performance issues of the original code by removing the calling overhead of the reaxff executable and the relatively slow file management. It also merged several modifications of the original code to support the usage of whole molecules for Monte Carlo moves, and supports the usage of multiple atom/molecule types during the simulation. Other improvements were made on the input options, the accessible volume calculation, the MC acceptance prefactor calculation and the writing of logfiles.

## 6.1.2 Input

A worked out GCMC exercise is available from a 2-day ReaxFF workshop (https://www.scm.com/adf-modeling-suite/adf-hands-on-workshops/advanced-2-day-reaxff-workshop/).

#### Overview

The GCMC code in ADF-ReaxFF needs the following input files to run:

- control\_MC : The GCMC control file, which holds MC settings and the atoms/molecules to insert/move/delete
- control: A reaxff control file, in which only a small number of parameters is of interest
- ffield: A standard reaxff forcefield file
- geo : A geometry file, preferably in biograph format (code not yet tested with xyz)
- iopt : Text file that should only contain a "5" (without the quotes)
- insertData\_MC : (optional file) Table used when restarting GCMC simulations

#### the control MC file

Lines in the control\_MC file that start with! or # will be ignored, so those can be used for comments. Empty lines are also ignored, so feel free to leave some in the file. Lines with keywords should have their value in the first 8 columns, followed by a couple of spaces (at least 1), followed by the 6-character keyword. The order is free, except for the nmols keyword, which should be the last one. The nmols keyword signals the parser that the next section of control\_MC will define X new MC Molecule Types.

This is an example for the control\_MC file:

The Molecule Specific Data blocks define the molecules (or atoms) that can be inserted/moved/deleted with the MC

code. The atoms named here should of course be in the forcefield files, and the coordinates should form a reasonable structure. The MC code uses these coordinates during the insertion step by giving them a random rotation, followed by a random translation to generate a random position of the molecule inside the box. Currently, there is no check to make sure the molecule stays inside the boundaries of the box, the code only checks that the rmaxpl/rminpl values are satisfied. If you plan on inserting large molecules, make sure there is enough room in the rmaxpl value, otherwise the code will stop with an error message.

#### The chemical potential (cmpot) keyword

The cmpot keyword sets the chemical potential of the molecule (or atom) reservoir, and is employed when calculating the Boltzmann accept/reject criteria after a MC move is executed. This value can be derived from first principles using statistical mechanics, or equivalently, it can be determined from thermochemical tables available in literature sources.

For example, the proper chemical potential for a GCMC simulation in which single oxygen atoms are exchanged with a reservoir of O2 gas, should equal 1/2 the chemical potential of O2 at the temperature and pressure of the reservoir:

```
cmpot = Mu_O(T,P) = 1/2*Mu_O(T,P) = 1/2*[Mu_ref(T,P_ref) + kT*Log(P/Pref) - E_diss]
```

where the reference chemical potential [Mu\_ref(T,P\_ref)] is the experimentally determined chemical potential of O2 at T and Pref, kT\*Log(P/Pref) is the pressure correction to the free energy, and E\_diss is the dissociation energy of the O2 molecule.

#### The no insert (noinsr) keyword

The noinsr keyword tells the GCMC code to keep the number of molecules/atoms of this type fixed. It will thus disable Insert/Delete moves on this type, meaning it can only do a displacement move, or volume change move (if the iensmb keyword is set to 1).

#### the control file

The control file is a regular reaxff control file and it influences the minimization step after an MC trial move. Because of this, only a small number of the reaxff keywords are used during the GCMC simulation.

An example of the control file:

The code has been tested with various imaxit and endmm values, the other options have not been fully tested. Other reaxff keywords might also influence the minimization procedure, but those are best left to their default settings

#### the ffield file

The ffield file should be an normal reaxff forcefield file, as described in the reaxff documentation by A. van Duin (visit the documentation section on the SCM website to obtain this document).

#### the geo file

The GCMC code has been tested with biograph input files, but other input formats might work. The details of this file are also described in the original reaxff documentation by van Duin.

## the iopt file

The iopt file is a text file with a single digit inside that selects the execution mode of the reaxff code. To run the GCMC code, this file should contain a "5" (without the quotes).

#### the insertData MC file

The GCMC code can insert multiple atom/molecule types in a single simulation, so it needs to keep track of what atom belongs to which insert. This information is automatically stored and updated when insertion/deletion/moving of atoms or molecules during the simulation, but is by default unknown of the atoms of the starting geometry. The GCMC code will therefore by default not modify the atoms in the original input in the MC trial moves (keep in mind that they can move around during the minimization step). the insertData\_MC file can be used to tell the GCMC code what atoms in the geo file belong to which molecule.

An example of the insertData MC file:

This example specifies 4 molecules/atoms that are modifiable by the GCMC code, belonging to 2 different GCMC molecules/atoms that are defined in the control\_MC file. The first "molecule" in the control\_MC file should thus consist of a single atom (if this doesn't match, the code will most likely crash!). It was inserted three times (atom 30, 47 and 48) The second molecule has two atoms, and was inserted once.

The atoms do not have a fixed order, and not all atoms have to be defined. If an atom is not appointed to a certain MCInsMolType and MCInsertNmbr, if will simply not be modified during the MC moves. The insertData\_MCXXXXXX files generated by the restart option of the code can be directly used as valid insertData\_MC files, just remove the digits from the filename and replace the geo file with the corresponding geo\_MCXXXXXX file.

## 6.1.3 Output

#### Overview

The GCMC code writes a couple of output files, each described in this section. It also produces a number of reaxff output files, and some of these are described in the original reaxff documentation by van Duin. Keep in mind that these files might not provide a complete or correct picture of the simulation, as they could also contain data originating from rejected MC trial moves.

#### geo MCXXXXXX

This file is generated every X accepted MC moves and contains the current geometry of the system in biograph format (X is set with the resfrq keyword in the control\_MC file).

#### insertData\_MCXXXXXX

This file contains a table of all the atoms in the system with their MC Molecule Type and MC Insert Number. This data can be used to map atoms to an inserted molecule, and is needed if you want to restart your calculation from an accepted MC step. The table contains -1 values for atoms that were in the original input and did not get a manually assigned MCInsert Molecule Type and MC Insert Number, the GCMC code will not modify these atoms during the MC steps.

Also see the section on insertData\_MC file.

### **MCstats**

The MCstats file is a logfile that contains the statistics of the MC simulation. The GCMC code writes a single line to it after every MC step, containing the number of: Tried MC moves (tried), Accepted MC moves (accept), Rejected MC moves (reject), Accepted Insertion/Deletion/Moving/Volume change MC moves (addAcc/delAcc/mvAcc/volAcc), Rejected Insertion/Deletion/Moving/Volume change MC moves (addRej/delRej/mvRej/volRej)

#### **Elog**

The Elog file contains the Volume and energies of the accepted MC steps. The energies in this logfile are the pure ReaxFF energy of the system (RxFFEnergy) and the MC corrected energy, which is used in determining if the step should be accepted or not (see the section on calculating energies for details).

#### reaxout.kf

This is the binary logfile generated by the GCMC code. Its contents can be viewed with the KFBrowser utility, or it can be loaded into ADFMovie to view the geometries in the file. Only the data of successful MC moves is written to this file.

## 6.1.4 Code Details

#### Overview

The GCMC code will perform niter (control\_MC file option) Grand Canonical Monte Carlo trial moves, and accept or reject them based on the Energy produced by the ReaxFF minimization step of the trial geometry. The Monte Carlo algorithm will always accept a step if it results in a decrease of the energy, and accept steps that go up in energy with a probability. This section will give some details about how the code works.

## MC Moves (Insert/Delete/Move/Volume)

The GCMC code currently supports 4 types of MC Moves: Insert, Delete, Move (displace), Volume change. The first three moves always change a whole "molecule" of the system, as defined in the control\_MC file (a molecule can of course contain only a single atom). Every MC iteration selects one MC Molecule Type from the defined molecules in control\_MC at random, followed by a random MC Move (unless there are no molecules of the type in the system, in that case it will do an insert move).

The Insert and Displace (move) MC Moves will generate a random rotation and position for the molecule, and then check if the random positions are within the "RminPl" and "RmaxPl" boundaries (this means no atom in the molecule can be closer to any atom currently in the system than "RminPl", and it should be within "RmaxPl" distance to an

atom in the system). If the conditions are not satisfied, a new set of coordinates is generated and the code checks again. This is repeated a maximum number of "nmctry" times before stopping with an error.

The volume change is controlled by the "ivlim" variable in control\_MC. The ivlim sets the volume change limit, and it should be a value between 0 and 1. The new volume will be calculated like this:  $V(x) = (1+iv)^{2} V(x)$ 

#### Calculating energies

Because the GCMC simulation adds and deletes atoms or molecules during the runtime, it cannot directly compare the ReaxFF energies for the MC acceptance criteria: inserting a molecule will usually lower the total energy of the system, causing the MC to always accept it, and always reject a deletion. To balance this out, the GCMC code calculates a "corrected" MC energy to compare the trial reaxFF energy with, consisting of the previously accepted ReaxFF energy + the chemical potential (cmpot in control)MC) for the inserted molecule, or the ReaxFF energy - the chemical potential for the deleted molecule. The volume change energy is also corrected, using the following formula:

 $E_MC_Corr = E_reaxff_last_accept - (Pressure * 0.1439 * (newV-oldV)) + ((1.0/beta) * nInsertedMols * log(newVavail/oldVavail))$ 

where new Vavail and old Vavail are calculated from the MC available volume (see the section calculating volumes).

#### **Calculating volumes**

The GCMC code can calculate the available volume in a couple of different ways, depending on the ivol setting in control\_MC:

- ivol = 0: volume = total volume occupied volume specified vacuum volume (vvacu)
- ivol = 1: volume = total cell volume
- ivol = 2: volume = specified accessible volume (vacc)
- ivol = 3: volume = total cell volume occupied volume
- ivol = 4: volume = specified accessible volume (vacc) occupied volume

Where the occupied volume is calculated by summing up the volumes of the atoms in the geo file that are not specified to be part of an MC type molecule. The volume of an atom is calculated using the average of the covalent atomic radius and the vd Waals radius of the atom, which are found in the reaxff forcefield file (ffield).

the vacc and vvacu options can be specified in the control\_MC file to get a more accurate available volume.

#### Acceptance criteria

An MC move is always accepted if the reaxff energy is lower than the corrected MC energy of the last accepted MC move, or if the energy increase is small enough. If the new energy is higher, the code generates a random number between 0 and 1, and accepts the move if the random number is bigger than:

```
prob = preFactor * exp(-Beta*deltaE)
```

Where the prefactor is calculated (for insert and delete moves) using the deBroglie wavelength of the inserted molecules, the number of inserted molecules and the available MC volume of the system.

# **6.2 Force-bias Monte Carlo (fbMC)**

The Uniform-acceptance force-bias Monte Carlo (fbMC) method (Phys. Rev. B 85, 134301 (2012) (https://doi.org/10.1103/PhysRevB.85.134301)) has been implemented in ADF ReaxFF by the group of Erik Neyts.

Usually, ReaxFF optimizations are alternated with fbMC steps to accelerate events such as reactions. The acceleration (MC step) is controlled by the temperature and maximum displacement, which should be balanced to keep close to the real dynamics. fbMC does not scale time uniformly (J. Chem. Phys. 141, 204104 (2014)

(https://doi.org/10.1063/1.4902136)). Diffusion coefficients and reaction rates should probably use quartic mass scaling.

fbMC mass scaling can be set. It defaults to quadratic scaling as in the original fbMC implementation. Setting *imcroo* to 4 would mean quartic mass scaling.

### Input keywords

These keywords should be set at the end of the *control* file. fbMC control parameters can also be set in the GUI.

- drmax maximum displacement
- *imcfrq* frequency of fbMC steps
- *imcstp* number of fbMC steps
- *imcroo* mass scaling (defaults to 2, 4 is recommended as per the Bal & Neyts paper)

A worked out example for fbMC versus unaccelerated ReaxFF MD for healing graphene has been made for the 2-day ReaxFF workshop (https://www.scm.com/adf-modeling-suite/adf-hands-on-workshops/advanced-2-day-reaxff-workshop/).

# 6.3 CVHD: Collective Variable-Driven Hyperdynamics

**Tip:** See also the advanced cvhd tutorial.

The CVHD implementation in Reaxff follows the algorithm described in K.M. Bal, E.C. Neyts, JCTC, 11 (2015) (https://doi.org/10.1021/acs.jctc.5b00597)

Currently only the bond-breaking collective variable is implemented. The CVHD takes a cvhd.in file as the only additional input. The file describes both the hyperdynamics and the collective variables and it has the following format:

The bias potential parameters are: startIter - the first iteration at which the bias potential is deposited, freqIter - bias potential deposition rate in steps, waitIter - number of steps to wait before removing the bias after CV becomes equal to 1, gaussHeight - height of a single gaussian deposited at a time in kcal/mol, gaussHalfWidth - gaussian delta of the deposited bias, wellTemperedT - the bias temperature as defined in [PhysRevLett 100, 020603 (2008)] (optional, the full bias is applied if wellTemperedT is absent).

The bond-breaking CV parameters: type = bond, AtomName1 and AtomName2 - atom names specified in the second atom name entry (the one after the coordinates) in the BGF-type geo file, which may be different from the element name specified before the coordinates; rmin and rmax - rmin and rmax from Eq 5 in the paper above, BOcutoff - bond order cutoff, bonds with BO below this value are not considered even of the bond distance is within the (rmin,rmax) interval; pExponent - corresponds to p in Eq 3 in the paper. The same pExponent value is used for all bond types but the rmin, rmax, and BOcutoff may (and should) be different.

An example cvhd.in file that one could use to reproduce the NVT pyrolysis modeling results from this paper (https://doi.org/10.1039/c6sc00498a) is given below:

## 6.4 The Molecule Gun

The molecule gun allows you to "shoot" (add with velocity) a molecule into the simulation box. Molecules can be continuously added to the simulation or only once. The initial position as well as the initial velocity can be pre-set or random w.r.t. to all or a selection of X,Y,Z-components. Possible applications of the molecule gun include e.g. the simulation of enforced collisions or deposition processes on surfaces.

#### See also:

Mol. Gun GUI tutorial

The molecule gun requires an additional input file called **addmol.bgf**. It contains the geometry of the particle to be shot in BGF format and some additional keywords.

The following keywords may be specified in the **addmol.bgf** file:

### **Input Keywords**

- FREQADD Add new molecule every N-th step but not before the iteration specified in FIRSTADD
- FIRSTADD Add the first molecule at iteration N
- VELADD Velocity of the added molecule: 1 random, 2 specified in the addmol.vel file, 3 via a temperature specified with TADDMOL
- STARTX The initial X coordinate of the added molecule, random if not specified
- STARTY The initial Y coordinate of the added molecule, random if not specified
- STARTZ The initial Z coordinate of the added molecule, random if not specified
- ADDIST Minimum distance from the molecule to other atoms for successful addition
- NATTEMPT The program will try to add a molecule N times until the ADDIST criterion is met
- TADDMOL for VELADD=1|3: temperature for the velocity of the molecule as a whole
- ROTATE The molecule is rotated randomly before being added
- SIGMAX sigma parameter for the Gauss distribution of the initial X coordinate around STARTX
- SIGMAY sigma parameter for the Gauss distribution of the initial Y coordinate around STARTY
- SIGMAZ sigma parameter for the Gauss distribution of the initial Z coordinate around STARTZ
- VELXYZ (Vx Vy Vz) for VELADD=3: the direction vector for the initial velocity of the added molecule
- SIGMAT for VELADD=1|3: standard deviation for TADDMOL
- TDISPER for VELADD=3: each atom's velocity is modified with  $V\{x,y,z\}$ =sqrt(RT/m)\*random\_normal(0,1)

## Example

The following example **addmol.bgf** file will create one carbon atom every 1000th iteration starting from iteration 500. The added atom will have an initial temperature of 800K and will initially move in the positive direction along the Z axis.

**Tip:** Use the GUI to setup a molecule gun calculation and edit the .run file created by the GUI to minimize typos. The section *addmol.bgf* is found at the end of the run file just before the *control* section.

#### Changes with respect to the original reac program

It is possible to add some randomness both to the pre-set position and to the velocity: the SIGMA{X,Y,Z} keywords specify a standard deviation value for the Gauss distribution around the START{X,Y,Z} values, respectively. If "ROTATE 1" is specified, the molecule will be rotated randomly around its geometric center before being added to the system.

A VELADD=3 option has been added. With this option, it is possible to specify the velocity vector's direction via VELXYZ. This vector is normalized so the exact magnitude of its components does not matter. The magnitude of the velocity along this vector is determined by the TADDMOL and SIGMAT parameters as sqrt(3nRT/M), where T=TADDMOL + SIGMAT\*random\_normal(0,1), n - number of atoms in the molecule, R - gas constant, M - molar mass. Additionally, the velocity of each atom may be modified with a random component based on the temperature specified by the TDISPER keyword. On average, the total temperature of the added molecules should be close to TADDMOL+TDISPER.

Molecules will never be added before the step specified by the FIRSTADD keyword. Thus, a molecule will always be added at the FIRSTADD step and then at every iteration divisible by FREQADD. If, for example, FIRSTADD=1999 and FREQADD=1000 then the first molecule will be added at iteration 1999, the second at iteration 2000 and then every 1000-th iteration after that.

# 6.5 Bond Boost Method

**Tip:** See also the advanced bond boost tutorial.

The bond boost method implemented here is described in [A. Vashisth, C. Ashraf, W. Zhang, C.E. Bakis, and A.C.T. van Duin, *Accelerated ReaxFF simulations for describing the reactive cross-linking of polymers*, J. Phys. Chem. A, 2018, 122 (32), 6633-6642]. In this method, the distances between atoms that are relevant to the reaction of interest are calculated to determine the orientation of the reactant molecules. If a suitable initial configuration is recognized, an additional restraint energy (possibly consisting of more than one term) is added to the system that is intended to

stretch or compress bonds at a pre-defined rate such that this additional energy can help achieve the energy to cross the reaction barrier. A single term of the restraint energy is given by

$$E_{ij}^{rest} = F_1 * (1 - e^{-F_2(R_{ij} - R_0)^2})$$

Where  $E_{ij}^{rest}$  - restraint energy between atoms i and j in kcal/mol;  $F_1$  and  $F_2$  - parameters for restraint energy in units of kcal/mol and  $^{-2}$ , respectively;  $R_0$  - target distance (in Å) between two atoms according to the restraint;  $R_{ij}$  - actual distance (in Å) between the two atoms under consideration.

The input for this method is given via the tracking in file, which has the following format:

A hash sign in the first position on a line begins a comment. The first non-comment line contains atom symbols and min/max distances for detection of the initial configuration. The first number (5 in the example above) specifies the number of atom pairs. For each pair, the minimum and maximum distances are specified and the first atom in each pair after the first corresponds to the second atom in the previous one. This means that the first element symbol in pair 2, 3, etc. is actually ignored. Thus, the example above defines a chain of atoms Si-O-H-O-Si-O with R(Si-O) in the (1.5,1.8) range and R(O-H) in the (0.9,1.3) range. It should be noted that when detecting the initial configuration, an atom may enter the chain more than once. This allows ring configurations to be specified although the ring must consist of at least 4 atoms.

**Note:** When detecting coordinates, the program uses alternative atom names specified after the atomic coordinates in the *geo* file. Since this name is generally not used to detect the ReaxFF element name, one can allow only a subset of A-B bonds to be boosted by giving certain atoms different alternative names. If more than one suitable configuration is found the one with the smallest sum of distances is used to create the restraints.

When a configuration matching these criteria is found, parameters specified on the second non-comment line are used to add restraints. The first number specifies the number of time-steps the restraint must remain active for (10000 in this case, which should be long enough for the reaction to take place). During this time no configuration detection is performed. In other words, only one set of restraints may be active at a given time. The second number on the line specifies the number of restraints to add (4 in this case). For each restraint, two indices and three parameters are specified. The indices correspond to positions of the atoms in the chain specified on the first line. In the example above, the restraint is set in such a way that the O2-H3 and Si5-O6 bonds are broken and Si5-O2 and O6-H3 bonds are formed. The results of the detection are written to the fort.84 file together with the imposed restraints.

## OTHER NEW FEATURES AND FIXES

# 7.1 Repeating the unit cells

A simple way to increase the size of the simulation box is by multiplying it a number of times in the a, b, and c directions. In the ReaxFF program this can be achieved by specifying the *reptx*, *repty*, and *reptz* keys (for the a, b, and c direction, respectively) in the control file. The specified value must be strictly positive and the default is 1 (one) for each of them.

# 7.2 Molecular charges

In order to freeze the total charge of a group of atoms (for example, a molecule) one can add a MOLCHARGE key to the geo file in the BGF format. The format of the key is as follows:

```
MOLCHARGE n1 n2 q
```

where n1 and n2 specify indices of the first and the last atoms of the molecule and q is the charge. All atoms between n1 and n2 will be included in the molecule. When specifying the MOLCHARGE key *all* atoms present in the system must be assigned to one of the the molecules. For example, if your system consists of 10 water molecules and the charge of the first of them is constrained to be +1 and the total charge of the system is zero then the following two MOLCHARGE keys must be specified:

**Note:** The MOLCHARGE is implemented as a simple constraint in the charge equilibration procedure and it does not take any bonding information into account. This means that specifying molecular charges using the MOLCHARGE key makes sense only if you are sure that the constitution of the molecule will not change during calculation. This is useful, for example, when fitting EEM-related parameters in a force-field.

## 7.3 External electric fields

External electric field regimes are specified in an external file eregime.in. The presence of this file in the ReaxFF run directory will activate the electric fields.

The format of this file is as follows:

**Note:** The electrostatic potential is sawtooth-like, which requires a vacuum zone (we suggest 10Å) on the box plane perpendicular to the efield vector. Otherwise one risks abnormal polarization for atoms on two sides of the plane. A good strategy to ensure the vacuum zone is to define an elastic wall restraint (see below).

#### Example:

Adding the following lines to your run script:

will overlay an external electric field with magnitude 0.01~V/Å in x-direction for the duration of 1000 iterations, then the magnitude is switched to -0.01~V/Å and kept for the rest of the simulation.

# 7.4 Elastic wall restraint

The wall is implemented as a  $cos^2(x)$  function (one period) between Coord-HalfWidth and Coord+HalfWidth with a maximum at Coord. The Height value is given in kcal/mole. At this moment, the elastic wall restraint can only be used with an orthorhombic unit cell.

The wall is specified in the geo file as:

```
EWALL RESTRAINT AxisIndex Coord HalfWidth Height
```

For example, for a wall that crosses the Z axis at z=7 Angstrom, is 2.0 Angstom thick and 100 kcal/mole high, the input would look like this:

**Note:** We recommended to set the icentr option in the control file to 0 to avoid inconsistencies between the initial atomic coordinates and the wall position.

# 7.5 ACKS2: Atom-condensed Kohn-Sham DFT approximated to second order

The ACKS2 charge equilibration scheme has been implemented following the original paper "ACKS2: Atom-condensed Kohn-Sham DFT approximated to second order" by T. Verstraelen et al. J. Chem. Phys. 138 (2013) 074108.

Using the ACKS2 scheme requires a suitable force-field, which is recognized by "[ acks2 ]" at the start of the first line of force field file (note: the spaces around "acks2" are important!). Besides, the *icharg* parameter in the control file must be set to 7. In addition to the general EEM parameters the ACKS2 scheme needs the general force-field parameter #35 ("Xamp") and the atomic cut-off parameter #23 ("softcut").

# 7.6 Correction for torsion angles asymptotics

There is a discontinuity problem for small bond orders in the expression for torsion angles and conjugation contributions f(BO). These terms correspond to expressions for  $f_{10}$  (eq. 10b) and  $f_{12}$  (eq. 11b) in the original ReaxFF paper (https://doi.org/10.1021/jp004368u). The new expression for each term in  $f_{10}$  is  $\left(1-e^{-2\lambda_{23}BO^2}\right)$  and in  $f_{12}$  the new expression is  $sin(\frac{\pi}{3}BO)^4$ . The new expressions ensure correct asymptotic behavior for the dE/dBO for BO  $\rightarrow$  0. Using this makes geometry optimizations more stable and improves conservation of energy during MD.

The correction can be enabled by setting the tors13 flag in the control file to 1.

# 7.7 LG dispersion

The LG dispersion correction was implemented following the paper Liu et al., \*ReaxFF-lg: Correction of the ReaxFF Reactive Force Field for London Dispersion, with Applications to the Equations of State for Energetic Materials\*, J. Phys. Chem. A, 2011, 115 (40), pp 11016–11022 (https://doi.org/10.1021/jp201599t)

The LG dispersion correction is turned on when using a suitable forcefield, which is recognized by the "[ lgDispersion=1 ]" key in the file header.

# 7.8 The rxffutil utility

Usage:

rxffutil command [arguments]

## 7.8.1 reformat

The **reformat** command tells rxffutil to read a (possibly mis-formatted) force-field file from standard input and write it in the format required by the ReaxFF program:

The result is written as a 'ffield' file in the current directory. The input can be almost free-format but the following points need to be taken into account:

• If you copy-paste force-field parameters from a pdf document (for example, from a publication's supporting info), then make sure to remove any page numbers that may have been copied together.

- The atom types section header (with the number of atom types in it) must have three comment lines following the line with the number of atom types.
- Likewise, the bond types section must have one comment line following the line with the number of bond types. Any comments provided on input are ignored and the standard comments are written instead.
- Numbers must be separated by at least one space

#### **7.8.2** minmax

The **minmax** command is intended for analyzing existing forcefield files. It will print the number of entries, as well as the minimum, maximum and average values for the given parameters:

```

#### Command arguments:

- - -ffdir=/path/to/ff/directory scan the specified directory for ff files when computing parameter ranges. The \$ADFRESOURCES/ForceFields/ReaxFF directory is used if this option is absent.
- *key* (mandatory) specifies which parameters to gather data for. Multiple keys may be specified. The syntax of the keys is as follows:
  - gen:i the i-th general parameter;
  - A:i the i-th item of the A atom type block;
  - b%AB:i the i-th item of the A-B bonds block;
  - o%AB:i the i-th item of the A-B off-diagonal block;
  - v%ABC:i the i-th item of the A-B-C valence angle block;
  - t%ABCD:i the i-th item of the A-B-C-D torsion angle block;
  - h%XHY:i the i-th item of the X-H-Y hydrogen bond block.

The index part of the key (:i) may be omitted, in which case the whole block is considered. In order to match *wildcard* torsions (indicated by 0 in the ff file) a question mark "?" instead of the atom type may be used. Examples of valid keys:

```
v%HPtH:1 - first parameter of the H-Pt-H valence angle block
v%HPtH - all parameters of the H-Pt-H valence angle block
t%?CC?:4 - fourth parameter of the *-C-C-* torsion angle block
```

Note that some angles may have more than one optimal value (for example 90 and 180 degrees), in which case ReaxFF may have more than one block per key in a force-field file. For such a key, the number of entries may be larger than the number of scanned files. In the following example, the number of entries for a C-O-O-C torsion is larger than that for the C-O bond because twelve force-fields contain two C-O-O-C torsion angles each:

One can see which files contain the given keys using the -vv verbosity option. There are three verbosity levels:

- $-v \log \text{ ff files as they are opened, read in and parsed;}$
- -vv as -v plus print a parameter value for each case of the found key together with the corresponding file and block index within the section;

• -vvv – as -vv plus print a key-block\_index pair for every block found when parsing ff files.

# 7.8.3 pdist

The **pdist** command can be used in addition to *minmax* to get a better idea about the parameter values distribution:

Keys used with the pdist command are required to have a non-empty index part. That is, v%HPtH is not a valid key while v%HPtH:1 is.

The number of points (bins) in the distribution is set by the - -npoints option (20 by default).

# **7.8.4 params**

The params command can be used to prepare a params file used by ReaxFF for force-field fitting:

```
rxffutil params [options] key ...
```

In additions to - -ffdir, the following options are available:

- - -ff=/path/to/ffield specify the ffield file for which the params file is to be created. If this option is omitted, the ffield file in he current directory is used. If there is no such file the program will quit.
- - -delta=real specify a value for the delta (or sigma) column of the params file (page 15) as a fraction of the corresponding min-max interval. The default value is 0.01.
- The min-max interval for each parameter is determined from parameter values (having the same key) found in the ffdir directory. This range is initially identical to the one printed by the minmax command but it can be modified using the following options:
  - - scalebound=real change the parameter range by scaling both boundaries by the specified factor. The boundaries are scaled in such a way that the range is expanded scalebound is greater than 1, or reduced otherwise. In other words, a negative lower bound is multiplied by the factor, while a positive one is divided. Likewise, a positive upper bound is multiplied by the factor, while a negative one is divided by it. This way, the bounds do not change their sign when extending or shrinking the parameter range (the scalebound must be positive);
  - - scalerange=real may be specified when the -scalebound option is is not used (otherwise it is ignored).
     If this option is present then the initial range is multiplied by the given factor and the lower and upper bounds are shifted symmetrically. Using this option may change the sign of the parameter boundary, which may lead to undesired consequences;
  - if none of the above options is specified then the lower and upper bounds may be scaled independently using the -scalemin=real and -scalemax=real options. When using this option the range can be expanded or shrunk depending on the sign of the boundary value.

For example, to get a params file for optimization of the C-O-O-C torsion angle parameters from the CHO-2016 force-field using MCFFOptimizer one can use the following commands:

In this example, the range is expanded by scaling the lower and upper bounds by 20% outwards. Exercise: run this command with and without the - -scalebound option and compare min max values.

When preparing a params file for the CMA-ES optimizer one should use the - -delta option to specify a suitably large initial sigma (typically in the order of 0.1 - 0.25).

**Note:** When optimizing valence and torsion angle parameters, care should be taken when selecting starting parameters for a parameters that are present more than once in the forcefield in question, e.g. the C-O-O-C torsion that has two optimal values in many force-fields. The average printed by the program is based on all entries so it will be somewhere in the middle between the optimal values, i.e. highly non-optimal.

**Note:** The fields in the output of the params command are sorted by the key (actually by its integer equivalent), while the output from the minmax command has an arbitrary order.

**Note:** When working on a real force-field fitting project one should not use the default ffdir value (\$ADFRE-SOURCES/ForceFields/ReaxFF). Instead, one should copy related ff files from there to a separate folder and use it. By related files one should understand, for example, the ones corresponding to the same branch (combustion or water) and/or having the same kind of non-bonding parameters (shielding/no-shielding, inner-core/no-inner-core).

## **TROUBLESHOOTING**

# 8.1 Geometry optimization

Geometry optimization issues with reaxff are usually caused by the fact that the derivative of the ReaxFF energy function has discontinuities. These discontinuities are often related to the bond order cutoff (cutof2 in the control file, 0.001 by default). This cutoff determines whether a valence or a torsion angle is included in the potential energy evaluation or not, i.e. when at least one of the bonds forming an angle is of order lower than the cutoff then the angle is discarded. Thus, when the order of a particular bond crosses the cutoff value between two optimization steps, the energy derivative (the force) experiences a sudden change. The magnitude of the jump depends on the cutoff value. The default value of 0.001 is normally not a problem during MD but it may break the geometry optimization convergence.

There are a two ways to reduce the discontinuity and thus to improve the stability of the geometry optimization. One way is to switch on the 2013 formula for the torsion angles (the tors13=1 key in the control file). This will make the torsion angles change more smoothly at lower bond orders but it will not affect the valence angles. You should be aware, however, that using this option changes the bond order dependence of the ReaxFF 4-center term.

The other way is to decrease the cutof2 value in the control file. This will significantly reduce the discontinuity in the valence angles and somewhat in the torsion angles but will not remove it. This will also make the calculation somewhat slower because more angles will have to be included in the computation.

## **REAXFF AS AN AMS ENGINE**

The ReaxFF AMS engine enables efficient parallel calculations using this empirical reactive molecular mechanics potential. The engine shares all core routines with the *standalone ReaxFF program* (page 1), guaranteeing identical energies and forces between these two codes.

The ReaxFF engine currently supports only molecular (free boundary) and 3D-periodic systems. Non-orthorhombic lattices are supported in an arbitrary orientation. However, the engine is slightly more computationally efficient when the cell is oriented according to the convention used in standalone ReaxFF, i.e. lattice vector c aligned with the z axis and vector b in the yz plane (zero x component). The Lattice block in the system definition then looks like this:

The only one input key required by the engine is ForceField, used to select the force field file. Force fields *included* in the Amsterdam Modeling Suite (page 49) can be easily accessed using their file name, such as CHO.ff.

The Torsions key can be used to enable the *improved torsion angle potential* (page 35). Although the original ReaxFF torsion potential is the default to preserve backward compatibility, the 2013 potential eliminates problematic energy discontinuities and works well with existing force fields.

**Description** Version of the torsion potential expression.

The engine can also be switched to a special non-reactive mode useful mainly for initial preparation of molecular dynamics simulations. This mode greatly reduces the occurrence of unwanted reactions when starting from an unrelaxed geometry. In these situations, we recommend running a short simulation with the NonReactive key to relieve the initial conformational strain and then restarting the MD run without this key.

Note that if you want to resume or extend an interrupted NonReactive run, it is recommended to also use the EngineRestart AMS key to supply the last ReaxFF .rkf file from the previous run. This enables the engine to

load the bonding topology used during the previous run and ensure that the simulation is seamlessly restarted. If the EngineRestart key is not used, bonds will be re-detected in the first step and then preserved during the rest of the simulation.

## **TECHNICAL TOPICS**

# 10.1 Hybrid parallelism

Reaxff, both as a program and as an AMS engine, has been parallelized using both MPI and OpenMP. MPI uses multiple processes to share the work, while OpenMP uses multiple threads within the same process. Each parallelization methods has its pluses and minuses. The OpenMP usually has a lower overhead than MPI but MPI can be used on a distributed-memory machine (compute cluster). It is possible to combine both methods in a single job, which may lead to a lower performance because of the double overhead. For small systems pure OpenMP can be much faster than hybrid OpenMP+MPI or pure MPI because of the relatively high cost of MPI communication.

## Number of OpenMP threads

The number of OpenMP threads is controlled by the OMP\_NUM\_THREADS environment variable. If OMP\_NUM\_THREADS is not defined the program will set the number of threads to the minimum of the default number of threads from the OpenMP library and the number of physical processor cores in the machine divided by the number of MPI processes running on it. The default number of threads returned by the OpenMP library depends on different factors: the number of the machine's virtual processors, the MPI and the OpenMP library used and the batch system, if any. For example, when running Reaxff on a quad-core desktop computer with hyperthreading (8 virtual processors) with IntelMPI using 4 MPI processes, the default number returned by the Intel OpenMP library will usually be 2 because the library is aware of the fact that it is running under MPI. The same OpenMP library running under a different MPI run-time, for example OpenMPI, will probably set the default number of threads to 8. In both cases, ReaxFF will use one OpenMP thread per process because it counts only physical cores and is aware of the job's MPI configuration.

When running under a batch system the default number of OpenMP threads will depend on the quality of integration of the batch system with the MPI runtime and the OpenMP library. For example, when running an IntelMPI version under SLURM, the number of threads should be set using the –cpus-per-task option to set the number of threads.

The OMP\_NUM\_THREADS environment variable's value overrides any defaults or heuristics when present.

#### Recommendations

For single-node calculations we recommend using pure OpenMP. To this end, set the NSCM environment variable to 1 and set OMP\_NUM\_THREADS to the number of processors to use or leave it undefined to use all cores.

When running on multiple nodes we recommend using pure MPI. To this end, set the OMP\_NUM\_THREADS environment variable to 1 and set other MPI-related options as you would do for any other AMS job. This is especially important if you are using an MPI runtime environment loosely integrated with the cluster's batch system.

## **WARNINGS**

**WARNING:** Inconsistent vdWaals-parameters in forcefield. See output All atom types in a force-field file should normally have consistent Van der Waals screening and short-range repulsion (a.k.a. inner core) parameters. This warning is printed if two atom types have inconsistent parameters.

**WARNING:** Suspicious force-field EEM parameters for ... For every atom type, the eta and gamma parameters for the electronegativity equalization method (EEM) should satisfy the relation: eta > 7.2\*gamma. Otherwise a polarization catastrophe is likely to occur at a short inteatomic distance, the critical distance being dependent on the eta/gamma ratio. The smaller the ratio the larger the distance at which this occurs. When the polarisation catastrophe occurs the amount of charge that flows from one atom to the other can become very large. The EEM routine checks that the resulting charge for each atom lies within the [-10,Z] interval, where Z is the number of electrons in the neutral atom, and throws an error if the check fails.

Disclaimer: Using these forcefields for systems they have not been explicitly trained against may produce unrealistic results. Please see the full manuscripts for more detailed information.

The force field files used by the SCM version of ReaxFF are compatible with those used by the original ReaxFF code. So if you have the force field information from somewhere else you can just use it (save it in a text file, and select it in ADFinput via the Other... option).

There are currently two major groupings (i.e., the ReaxFF branches) of parameter sets that are intra-transferable with one another: (1) the combustion branch and (2) the aqueous (water) branch. The major difference between these two branches is in the O/H parameters, where the combustion branch focuses on accurately describing water as a gas-phase molecule, and the water branch is targeted at aqueous chemistry.

### 14.1.1 Format

The force field file begins with a description line that, in turn, may optionally begin with a list of keywords between square brackets, for example (for an ACKS2+eReaxff force-field):

Each section starts with one or more header line containing, on the first line, the number of blocks in the section, possibly followed by description of the parameters. The number of header lines is supposed to match the number lines in a block of the corresponding section (4 in atoms, 2 in bonds and 1 in every other section). The additional header lines after the first are skipped when reading the force field file.

#### **General parameters**

The header of this section starts with *npar*, the number of general parameters present in the force field file. The ehader is followed by *npar* lines each containing a parameter value followed by a comment, for example:

#### **Atoms**

The atomic parameters section starts with the number of atom types present in the force field, followed by three additional header lines and the blocks of parameters, one block per atom type. Each block consists of 4 lines starting with a line containing the atom name and 8 parameter values with the (1x,a2,8f9.4) format followed by three lines with 8 parameter values each, with the (3x,8f9.4) format, for example:

#### Bonds, angles, etc.

In the remaining sections, a block key consists of two or more integer numbers, each of them referring to the atomic block with this index. The number of integers in the key depends on the block type (two for bonds, three for valence angles, etc.). For instance, the bond parameters block below corresponds to the C-H bond for the atoms block shown above.

The bond parameters section starts with the number of bond types followed by one additional comment line. The first line of the block has the (2i3,8f9.4) format and the second (6x,8f9.4):

For the rest of the sections, the format remains similar to the bonds section, except that they do not have additional header lines and the Fortran format may be slightly different: (2i3,6f9.4) for off-diagonal,(3i3,7f9.4) for valence angles, (4i3,7f9.4) for torsion angles, and (3i3,4f9.4) for hydrogen bonds.

## 14.1.2 Equation Reference

In the tables below the ReaxFF parameters are listed with their corresponding equation numbers from the SCM developer notes which have mostly technical relevance. For a good introduction to the meaning of ReaxFF parameters we advise the initial ReaxFF publication ReaxFF: A Reactive Force Field for Hydrocarbons, A.C.T. van Duin, S. Dasgupta, F. Lorant, W.A. #### General

Of particular interest are the upper taper radius parameter (#13), which describes the non-bonded cutoff radius, and the bond order cutoff (#30), which describes the bond order threshold, above which atoms are considered connected. Both these parameters may have a major impact on the ReaxFF calculation speed; decreasing the taper radius or increasing the bond order cutoff can make ReaxFF run considerably faster. These parameters, however, have a significant impact on the force description and should not be changed without re-parameterization of other parts of the force field.

## 14.2 trainset.in

## 14.2.1 Description of the trainset.in file

The trainset.in file contains the training set data and tells the program how to calculate the cost function  $F = \Sigma((y_i - y_i^{ref})/acc_i)^2$ , which can be used to optimize the *force field* (page 77) parameters. The **trainset.in** uses molecule identifiers, or keys, defined in the DESCRP field of the geo file (in BGF format), or in the models.in file, to compare force field derived geometries and energy differences to the reference values. The **trainset.in** has a free format as far as numbers concerned, although it does require that fields are space-separated. Besides, the "-", "+" and "/" symbols have a special meaning in the **trainset.in** file and should not be used in identifiers. The **trainset.in** file is divided into 5 sections listed below. Each section begins with a start keyword and ends with the corresponding end keyword. The words in "CELL PARAMETERS" and "ENDCELL PARAMETERS" must be separated by exactly one space.

"**Acc**" is a value of the target accuracy desired for the given error function contribution. This value is often called "**weight**" although in practice it is 1/weight. "**Ref**" is the reference value.

## 14.2.3 Format description

In the all sections except "ENERGY" each data line starts with the structure identifier (the **Key**), followed by the "**Acc**" of the data point. This is followed by a type identifier. Each section contains following data entries:

• **CHARGE** In the CHARGE section the type identifier is the number of the atom in the molecule and the reference value is its charge. Example:

• **GEOMETRY** In the GEOMETRY section the type ID is the list of atoms defining an internal coordinate (two for an interactomic distance, three for a valence and four for a torsion angle). When there is only one atom index specified, then the Eucledian distance for the given atom between the two geometries is calculated. When the index is -1 then an average Eucledian distance quantity between the two geometries is used instead. Please note that any reference value different from zero for the Eucledian distances does not make much sense. Besides, since these distances are computed in the Cartesian coordinates, which means that a simple translation of the molecule as a result of energy minimization may result in large Eucledian distances for otherwise similar geometries. If there is no identifier provided then it means that the ReaxFF RMS force will be compared with the reference (which should probably be zero in most cases). Example:

• ENERGY This section allows comparison of ReaxFF energy differences between structures to the reference data. In this case, each data line starts with the Acc of the data point, followed by up to five operator/identifier/divider parts and finishes with the reference value. The operator is either '+' or '-' ('+' is the default). The energy associated with the identifier is divided by the divider, allowing comparison of condensed structures to monomers. The '/' character in the ENERGY section data lines is optional. Example:
